Provides resources and answers frequently asked questions related to telehealth and health information technology (HIT) in a rural setting. Discusses opportunities for these technologies to improve healthcare delivery, staffing, privacy, cybersecurity, broadband access, and other related topics.

Fundraising Tips

- Check with businesses and organizations operating in your area. Corporations, banks, and other local businesses often fund projects that will benefit the areas in which they operate. Especially if you are looking for a small amount, these organizations can be valuable sources of funding.
- Reach out to civic organizations. Local civic and faith-based organizations typically have small amounts of funding available for community needs, or they may consider hosting a fundraiser on behalf of your organization. Examples include American Legion, churches, church groups, Civitan, Elks, Kiwanis, Lions, Moose, Pilot, Moose, Rotary, and VFW. Contact members of the organizations/congregations to ask if they have a donation or sponsorship process.
- Get help from nonprofit organization associations. The <u>National Council of Nonprofits</u> has <u>state association members</u> in almost every state. The associations support nonprofit organizations in meeting their missions by providing training, resources, and policy support. Many provide grant writing and resource development training and additional support to develop nonprofit capacity in their state.

- Get technical assistance. There are several organizations that may provide technical assistance for rural organizations seeking grants. All states have a designated <u>State Office of Rural Health (SORH)</u>, and many SORHs will provide grant writing training, guidance during the writing process, or review and critique of completed grant proposals. Many <u>State Rural Health Associations</u> and <u>State Primary Care Associations</u> provide training programs and technical assistance for grant writers working with rural health organizations. In addition, some <u>foundations and public agencies</u> will provide training, grant writing assistance, or funding to hire a contractor.
- Be prepared when reaching out to potential funders. Be ready to answer basic questions about the project, such as:
 - Overall concept
 - o Budgetary needs
 - Funding already in hand
 - Partners who are involved
 - How the project can add value to the funder's mission
- **Build your own scale.** The primary issue with large foundations supporting rural organizations is scale. This is a strong cohort of RPHWTN awardees working in 4 very clear critical workforce areas. Consider partnering with networks working in the same area and prepare a single proposal to a large foundation.

Finding Scholarships, Loan Repayment, and Training Funding

The first place to start seeking financial assistance for education and training is the educational institution's financial aid office. Resources and additional places to search for scholarships, loan repayment, and training funding are listed below.

National Funding Programs

- <u>Ascendium Philanthropy:</u> Works to overcome the academic, financial, and social barriers to postsecondary education. Supports research organizations, colleges, workforce training providers, and large-scale initiatives. Award amounts are variable.
- <u>Bank of America Foundation</u>: Relevant priority areas include workforce development and education, basic needs like food and housing, and community development. More information is provided in the <u>FAQs</u>. Nonprofits organizations and programs are eligible. Awards have been up to \$500,000. Most awards are \$5,000 or below.
- <u>BNSF Foundation</u>: Health and human services are a program priority. Applicants must be 501(c)(3) nonprofits, divisions of local government, federally recognized tribal governments, or schools/universities. Between \$1,000 and \$10,000 is available.
- <u>Caterpillar Foundation</u>: Projects could fit under the workforce category. Nonprofits organizations and programs are eligible. Awards have been up to \$1,000,000. Most awards are \$5,000 or below.
- <u>ECMC Foundation</u>: Funding priorities include rural impact and postsecondary completion. Nonprofit organizations registered as a U.S. 501(c)(3) or a 509(a)(1), (2) or (3) of the Internal Revenue Code, government entities, and postsecondary institutions or systems or their affiliated and supporting foundations. Award amounts are variable.
- <u>GEICO Philanthropic Foundation</u>: Health and wellness are program priorities. Nonprofit organizations and programs are eligible. Award amounts are not stated.
- <u>Hearst Foundations Health Grants</u>: The Hearst Foundations provide program, capital, and endowment support grants for organizations working to address access to healthcare for high-need populations, healthcare professional shortages, evolving healthcare demands, and medical research. Eligible applicants are 501(c)(3) nonprofit organizations operating in the United States. Minimum \$100,000 is available.
- Johnson & Johnson Foundation: Supports programs designed to promote women and children's health; strengthen healthcare workforce; ensure access to essential surgery; address global disease challenges through innovative solutions; and foster disaster relief and product donations. Nonprofits organizations and programs are eligible. Awards have been up to \$25,000. Most awards are \$5,000 or below.
- <u>Rotary Grants</u>: District grants fund small-scale, short-term activities that address needs in your community and communities abroad. Applicants must be Rotary members. Contact the Rotary Clubs in your area.
- <u>State Farm Community Grants</u>: Projects could fall under community development and/or education. It is best to contact your local State Farm agent to discuss the project.

 <u>Walmart Local Community Grants</u>: You can apply for up to \$5,000 from each Walmart, Sam's Club, or distribution center within the retail catchment area. Contact a store/center manager before applying. Applications tend to get lost in Walmart's grant system. See the <u>Walmart Store Directory</u> and <u>Sam's Club Locator</u>.

State and Regional Funding Programs

Florida

- <u>Ameriprise Financial</u>: Grants for projects in the areas of hunger, shelter, self-sufficiency, and community vitality. Nonprofit organizations are eligible. Award amounts are not stated.
- <u>Community Foundation for Brevard</u>: Community foundations are interested in funding projects related to local community wellbeing. They typically have multiple funds with different requirements (called donor-advised funds). Contact the community foundations to: (1) Discuss the project; (2) Ask if they have funds that may fit the project; and (3) Ask if they know of any other funding that may fit.
- <u>Community Foundation of North Central Florida</u>: Community foundations are interested in funding projects related to local community wellbeing. They typically have multiple funds with different requirements (called donor-advised funds). Contact the community foundations to: (1) Discuss the project; (2) Ask if they have funds that may fit the project; and (3) Ask if they know of any other funding that may fit.
- <u>Community Foundation of Northwest Florida</u>: Community foundations are interested in funding projects related to local community wellbeing. They typically have multiple funds with different requirements (called donor-advised funds). Contact the community foundations to: (1) Discuss the project; (2) Ask if they have funds that may fit the project; and (3) Ask if they know of any other funding that may fit.
- <u>Duke Energy Foundation</u>: Priorities that may fit include community revitalization and local economic development efforts, supporting upward mobility for families and individuals, and programs reducing structural barriers and promoting access to opportunity for underserved communities. Franklin and Taylor Counties are in the service area. Eligible organizations include 501(c)(3) organizations and government entities. Up to \$20,000 available.
- <u>First Citizens Bank</u>: Priorities include empowerment to communities. Eligible organizations are 501(c)(3) organizations. Between \$2,500 and \$50,000 available depending on the size of the market.
- <u>Florida Blue Foundation</u>: Focus areas are healthy communities, food security, health equity, and mental wellbeing. Deadlines and application cycles are discussed on the site.
- <u>Space Coast Health Foundation</u>: They are in the process of updating their grantmaking model. Contact them at <u>info@schfbrevard.org</u>.
- <u>Truist Foundation</u>: Depending on the project, it should fit within the "building career pathways to economic mobility" focus area.

<u>Weyerhaeuser Company Foundation</u>: Focus areas are affordable housing; education and youth development; environmental stewardship; human services; civic and cultural growth; workforce development; and diversity, equity and inclusion. When looking at the "Where we give tab," be sure to check the Timberlands counties. Eligible organizations include 501(c)(3) organizations, public education institutions, and government entities. Amount available varies.

Georgia

- <u>Community Foundation of Coffee County</u>: Community foundations are interested in funding projects related to local community wellbeing. They typically have multiple funds with different requirements (called donor-advised funds). Contact the community foundations to: (1) Discuss the project; (2) Ask if they have funds that may fit the project; and (3) Ask if they know of any other funding that may fit.
- <u>Community Foundation of South Georgia</u>: Community foundations are interested in funding projects related to local community wellbeing. They typically have multiple funds with different requirements (called donor-advised funds). Contact the community foundations to: (1) Discuss the project; (2) Ask if they have funds that may fit the project; and (3) Ask if they know of any other funding that may fit.
- <u>Constellation Fund</u>: Funds established interventions with the potential to scale or organizations with the potential to grow. Eligible applicants are nonprofit organizations and programs. Award amounts are not stated.
- <u>First Citizens Bank</u>: Priorities include empowerment to communities. Eligible organizations are 501(c)(3) organizations. Between \$2,500 and \$50,000 available depending on the size of the market.
- <u>Georgia Dual Track Rural Hospital Support Grant for Hospital Stabilization or Graduate</u> <u>Medical Education:</u> Grants for rural hospitals in Georgia to increase or expand access to healthcare, support recruitment and retention initiatives, reduce existing debt, or strengthen financial and operational foundation/reduce financial waste. Eligible applicants must be rural or have a CAH in county and be listed on Rural Hospital Tax Credit 2023 Ranking of Financial Need. Between \$250,000 and \$1 million is available.
- <u>Georgia Farm Bureau</u>: Farm Bureau is a member of the Clinch Chamber. Contact them to discuss donations.
- Georgia Power: The project may fit under the "workforce for Georgia" program area.
- <u>Regions Bank:</u> Addresses social and economic issues, assists in building inclusive economic prosperity, and helps more member communities benefit from the rewards of a growing economy. Eligible applicants include nonprofit organizations, local businesses, and government and service agencies. Award amounts are not stated.
- Weyerhaeuser Company Foundation: Focus areas are affordable housing; education and youth development; environmental stewardship; human services; civic and cultural growth; workforce development; and diversity, equity and inclusion. When looking at the "Where we give tab," be sure to check the Timberlands counties. Eligible organizations include 501(c)(3) organizations, public education institutions, and government entities. Amount available varies.

Illinois

- <u>Ameren</u>: Focus areas include economic empowerment, critical needs, and thriving communities. Eligible applicants are 501(c)(3) nonprofit organizations in the Ameren Missouri or Illinois service areas. Award amounts are not stated.
- <u>Ameriprise Financial</u>: Grants for projects in the areas of hunger, shelter, self-sufficiency, and community vitality. Nonprofit organizations are eligible. Award amounts are not stated.
- <u>Blue Cross Blue Shield of Illinois</u>: Focus areas are economic opportunity and stability, food access and nutrition, neighborhood and built environment, locally defined health solutions, and optimal health outcomes. Eligible applicants are 501(c)(3) nonprofit organizations. Between \$25,000 and \$100,000 is available.
- <u>Community Foundation Serving West Central Illinois and Northeast Missouri</u>: Grants to advance arts and culture, community betterment, education, health, and human services in a 12-county region. Eligible applicants include 501(c)(3) nonprofit organizations or their fiscal sponsor, units of government or municipalities for public/charitable purposes, and faith-based organizations for projects that are open to community regardless of religion and do no promote or require religious doctrine. Between \$1,000 and \$7,500 is available.
- <u>Community Foundations</u>: There are many community foundations in Illinois. Search the Community Foundation Locator with the project location. Contact community foundations to discuss the project and ask if they know of funding programs that will fit.
- <u>Compeer Financial General Use Grant</u>: Project may fit within the quality-of-life focus. Applicants must work within Compeer Financial's <u>144 county territory</u>. Up to \$10,000 is available.
- <u>Constellation Fund</u>: Funds established interventions with the potential to scale or organizations with the potential to grow. Eligible applicants are nonprofit organizations and programs. Award amounts are not stated.
- <u>Target Local Neighborhood Support</u>: Download the form to request gift card donations from the local store. Eligible applicants are 501(c)(3) nonprofit organizations, accredited schools, or public agencies. An average donation is \$25-50 with the maximum donation of \$500 per year, per agency
- <u>Telligen Community Initiative Grants</u>: Grants for programs and nonprofit organizations that address social determinants that impact health and enhance equity, that are making healthcare education more accessible, and that are fostering healthcare. Eligible applicants are 501(c)(3) nonprofit organizations, accredited schools, and public/ governmental agencies located in the states of Colorado, Illinois, Iowa, and Oklahoma. Up to \$75,000 is available.

• <u>Union Pacific Community Ties Giving Program</u>: Projects could possibly fit under workforce and/or community vitality. Eligible applicants are nonprofit organizations with 501(c)(3) status. Up to \$30,000 is available.

Iowa

- <u>Alliant Energy Foundation Community Grants</u>: Funding for community projects in the areas of rural hunger, housing, workforce, environmental stewardship, and community safety/engagement. Eligible organizations are public charities in Iowa, Minnesota, and Wisconsin. Awards are typically \$5,000 or less.
- <u>Ameriprise Financial</u>: Grants for projects in the areas of hunger, shelter, self-sufficiency, and community vitality. Nonprofit organizations are eligible. Award amounts are not stated.
- Farm Bureau Financial Services: Projects could fall under the families & communities and health & wellness program areas. Eligible applicants are 501(c)(3) organizations. Award amounts are not stated.
- <u>Greater Jefferson County Foundation</u>: Community foundations are interested in funding projects related to local community wellbeing. They typically have multiple funds with different requirements (called donor-advised funds). Contact the community foundations to: (1) Discuss the project; (2) Ask if they have funds that may fit the project; and (3) Ask if they know of any other funding that may fit. Grants have been awarded in Scott, Polk, and Wapello Counties, so they have given outside of Jefferson County.
- <u>Iowa Farm Bureau Sponsorship Program</u>: Priorities include health/wellness, agriculture, youth and education, and farm families and communities. Eligible institutions are nonprofit organizations with 501(c)(3) status. Amounts are not specified.
- <u>Keokuk Area Community Foundation</u>: Community foundations are interested in funding projects related to local community wellbeing. They typically have multiple funds with different requirements (called donor-advised funds). Contact the community foundations to: (1) Discuss the project; (2) Ask if they have funds that may fit the project; and (3) Ask if they know of any other funding that may fit.
- MFA Oil Foundation: The MFA Oil Foundation provides cash grants to support nonprofit organizations that are working to improve communities where MFA Oil has a significant concentration of members and employees. The Foundation's mission is to assist rural communities in MFA Oil Company's market area by donating resources that help develop and strengthen organizations dedicated to education, youth, human services or civic endeavors. Eligible applicants are 501(c)(3) nonprofit organizations in communities where MFA Oil has a significant concentration of members and employees in Iowa, Kansas, Missouri, Indiana, Oklahoma, Arkansas, Kentucky, and Tennessee. Up to \$2,000 is available.

- North Lee Community Foundation: Community foundations are interested in funding projects related to local community wellbeing. They typically have multiple funds with different requirements (called donor-advised funds). Contact the community foundations to: (1) Discuss the project; (2) Ask if they have funds that may fit the project; and (3) Ask if they know of any other funding that may fit.
- <u>Telligen Community Initiative Grants</u>: Grants for programs and nonprofit organizations that address social determinants that impact health and enhance equity, that are making healthcare education more accessible, and that are fostering healthcare. Eligible applicants are 501(c)(3) nonprofit organizations, accredited schools, and public/ governmental agencies located in the states of Colorado, Illinois, Iowa, and Oklahoma. Up to \$75,000 is available.
- <u>Union Pacific Community Ties Giving Program</u>: Projects could possibly fit under workforce and/or community vitality. Eligible institutions are nonprofit organizations with 501(c)(3) status. Up to \$30,000 is available.
- <u>Wellmark Foundation</u>: Funds organizations and projects that positively impact the health of Iowans and South Dakotans. Eligible applicants are nonprofit organizations. Award amounts are not stated.

Kansas

- <u>Blue Cross Blue Shield of Kansas Foundation</u>: The Foundation seeks opportunities to fund programs and activities that promote health improvement, community health access and/or health education, healthy behaviors, prevention initiatives and direct health services to the uninsured. Eligible applicants are nonprofit organizations with 501(c)(3) status working in the Foundation's 103 county service area. Contact marlou.wegener@bcbsks.com or 785.291.7246 to discuss grants over \$5,000.
- <u>Community Foundation of Ellis</u>: Preference will be given to tangible, long-lived community assets. Groups encouraged to participate are nonprofit groups recognized by the State of Kansas or the Federal Government, such as Girl Scouts, Boy Scouts, church youth organizations, school groups, tax-supported organizations, and tax-exempt agencies. Amounts typically do not exceed \$1,000.
- <u>Community Foundations</u>: There are many community foundations in Kansas. Search the Community Foundation Locator with the project location. Contact community foundations to discuss the project and ask if they know of funding programs that will fit.
- <u>Dane G. Hansen Foundation</u>: The Foundation accepts grant applications for programs or projects that benefit the people and communities of Northwest Kansas. Funding priorities include healthcare access, economic development, and education. Eligible applicants will be either 501(c)(3) organizations, governmental bodies, and organizations that qualify under a blanket exemption ruling granted to the parent organization. Applicants must be in or benefit residents of the primary service area which includes the 26 most northwest Kansas counties. Award amounts are variable.
- <u>Emprise Bank:</u> Priorities include civic engagement, financial literacy, arts and culture, and health and human services. Amounts available not stated.
- <u>Farm Bureau Financial Services</u>: Projects could fall under the families & communities and health & wellness program areas. Eligible applicants are 501(c)(3) organizations. Award amounts are not stated.
- <u>First Citizens Bank</u>: Priorities include empowerment to communities. Eligible organizations are 501(c)(3) organizations. Between \$2,500 and \$50,000 available depending on the size of the market.
- <u>Greater Kansas City Community Foundation</u>: Community foundations are interested in funding projects related to local community wellbeing. They typically have multiple funds with different requirements (called donor-advised funds). Contact the community foundations to: (1) Discuss the project; (2) Ask if they have funds that may fit the project; and (3) Ask if they know of any other funding that may fit.

- <u>Greater Salina Community Foundation</u>: Works to build permanent endowment funds and meet charitable community needs. Eligible applicants are 501(c)(3) organizations, educational institutions, government agencies, and religious organizations working in the area served by the Foundation. Award amounts are variable.
- <u>Heartland Community Foundation</u>: The Heartland Community Foundation connects donors to important charitable causes in Ellis, Rooks, and Trego counties, in Northwest Kansas. Eligible applicants are 501(c)(3) organizations, educational institutions, government agencies, and religious organizations working in the area served by the HCF. Award amounts are variable.
- <u>Kansas Department of Commerce</u>: Funding for training and equipment to address workforce shortages. The last grants were awarded in 2023. Contact to see if the funding is continuing. Eligible applicants include mobile workforce training providers; healthcare providers; education providers; technology-based businesses; and employers working with persons with disabilities. Past awards were around \$65,000 - \$740,000.
- <u>Kansas Health Foundation</u>: Priorities include major health challenges, community impact, and civic life and policy. See <u>current opportunities</u> available.
- Leo J. Dreiling and Albina Dreiling Charitable Trust: Has previously funded healthcare related organizations. Call 785.625.5533 for more information.
