Key and essential resources, tools, and training for rural healthcare systems preparing for and responding to a COVID-19 surge. The resources span a wide range of healthcare settings and cover a broad array of topics ranging from behavioral health to healthcare operations to telehealth.



Developed in 2020 by the COVID-19 Healthcare Resilience Working Group, a partnership with the U.S. Department of Health & Human Services, the U.S. Department of Homeland Security and other federal agencies to provide support and guidance for healthcare delivery and workforce capacity and protection.
